JOYCE NOVOTNY-PRETTIMAN FINDS VICTORY IN REVOLUTIONARY PA SUPREME COURT CASE

Attorney Joyce Novotny-Prettiman of the law firm of QuatriniRafferty recently obtained a significant victory for all Pennsylvania motorists in the case of Gallagher v. GEICO Indemnity Company decided on January 23, 2019.

The Supreme Court of Pennsylvania found that the "household exclusion" provision that is contained in many auto and motorcycle policies violates the Pennsylvania Motor Vehicle Financial Responsibility Law. The "household exclusion" applies to uninsured and underinsured motorist coverage (UM/UIM) in auto and motorcycle policies. Attorney Novotny-Prettiman's victory in Gallagher v. GEICO struck down the "household exclusion." This means if you elect to "stack" UM/UIM insurance coverages, all of the insured vehicles in a household – autos and motorcycles - are added together to determine the amount of available coverage. Previously, even if you purchased "stacked" UM/UIM coverage and paid an extra premium for that coverage, the "household exclusion" would take that coverage away. For example, in a Pennsylvania household where there are three vehicles and two motorcycles with UM/UIM coverage and "stacking" on the insurance policies, any resident relative in the household who is injured in an auto or motorcycle collision is now eligible to receive UM/ UIM coverage from all five vehicles in the household. This change is particularly important for motorcyclists in Pennsylvania who in the past have generally been forced to insure their motorcycles under separate policies. "This is a big deal," said Vince Quatrini, managing partner at QuatriniRafferty. "Very few cases get to the Supreme Court. And, even fewer cases change Pennsylvania law. Joyce Novotny-Prettiman did both. We are very proud of this major win for all Pennsylvania drivers!"

Novotny-Prettiman advises that all drivers purchase "stacked" UM/UIM coverage, especially after this Supreme Court Decision. "If you have a question about your insurance coverage, please give me a call and I will review your policy with you. This case will also impact other factual scenarios dealing with interactions of household policies, so you need legal advice even if you did not elect to stack your UM/UIM coverage if you have been denied coverage."

- Pawlosky v. Latrobe Brewing Co.: Ranked by Workers' Compensation practitioners as the third most important case in the past 100 years, Vince Quatrini convinced the Supreme Court of Pennsylvania to dramatically redefine the term "injury" under the Workers' Compensation Act; namely, any disease which constitutes an insult to the body as well as any work-related aggravation of a nonoccupational disease are considered injuries.
- McIlvaine v. States: As a result of this decision, any individual who is hurt while working in Pennsylvania no matter what state that person lives in or hired in is protected by the Pennsylvania Workers' Compensation Act. If you are hurt in Pennsylvania, you are covered in Pennsylvania.
- Camaione v. Boro of Latrobe: In this case, the Pennsylvania Supreme Court ruled that all injured workers being paid under

the Heart and Lung Act are entitled to a hearing in order to determine eligibility.

In addition to our work inside the courtroom, QR attorneys continue to be the featured authors – and teachers – for Pennsylvania Bar Institute programs on Workers' Compensation and Social Security Disability. In essence, QR literally "writes the book" on both areas of the law!

DISCUSSING YOU AND YOUR AUTO INSURANCE

How often do you think about your auto insurance policy? Probably not very much. Most people purchase a policy and never review it again. Just as your needs change in other areas of your life as you age, so too do your needs with regard to your auto insurance.

In this article, I'll suggest some changes to your auto policy as you move through the different decades of your life. Please share this with friends and family and also remember that we are happy to review your auto insurance policy with you for free. Just give us a call!

Teens - Early 20s

If you're at a point in your life where you cannot afford more than a basic auto insurance policy, we understand that. However, before buying the cheapest policy, always ask your agent what the price difference is between FULL or LIMITED TORT. If you can afford FULL TORT, ALWAYS purchase FULL TORT. If you purchase FULL TORT and you are injured in an auto accident through no fault of your own, you are permitted to make a claim against the at-fault driver's insurance company for your pain and suffering. If you selected LIMITED TORT, generally, you are not permitted to make such a recovery.

20s - 30s

As you get a little older, you may have a family you are worried about protecting. You also may have the financial means to purchase a more comprehensive auto insurance policy. When you get married, if you and your spouse each own a vehicle and they are covered under two separate auto insurance policies, you should discuss purchasing a joint policy with STACKED COVERAGE. You also want to make sure that you have an equal amount of UNINSURED and UNDERINSURED MOTORIST COVERAGE as liability coverage. Uninsured and underinsured motorist coverage protects you and your family in the event that the individual who caused the accident has no insurance or not enough insurance to cover all of your injuries, pain, suffering, inconvenience, medical bills, and lost wages.

The coverages that I mentioned so far are paid in lump sum payments. That is, these payments are not made until your case is completed - either through a settlement or trial. Depending on the circumstances of your accident, this can take months or even years. If you are unable to work because of injuries sustained in an accident, it is important for you to have income available to pay your bills. To accomplish this, purchase WAGE LOSS COVERAGE. This coverage will provide you with payments on a monthly basis.

40s - 50s

At this point, you may have kids who are starting to drive which will increase your insurance rates. Having said that, if you can afford to keep FULL TORT + UNINSURED/UNDERINSURED + STACKED COVERAGE -- you should. If you have to change something, DO NOT switch to LIMITED TORT. Talk with your agent and with us before making any changes in an effort to save money.

60s+

At this age, your kids are out of the house and you may be thinking about retirement. If you are retired, your income would come through Social Security, your pension, or other retirement accounts. As such, WAGE LOSS COVERAGE on your policy does not provide you with any benefit – so you can stop paying for that coverage.


