# THE NEW MEDICARE PRESCRIPTION DRUG COVERAGE -

Medicare has now changed to include prescription drug coverage, known as Medicare Part D. This coverage is supplemental to Medicare Parts A and B and is not offered directly from Medicare, but is private insurance coverage that you purchase just as you would any other health insurance policy. Medicare is underwriting part of the cost of this insurance, so that those who purchase it pay a reduced monthly premium. Persons of limited resources may receive additional help with the payment of their premiums.

Medicare Part D prescription coverage is not a discount drug card. It requires you to choose a private prescription drug plan. The plan you choose will require that you pay deductibles and co-pays for prescription medications, up to certain limits per month and/or per year. There are many plans, and each covers different medications. You should carefully choose the plan that provides payment for the medications that you are taking.

# TAX TALK WITH JIM

Since April 15 falls on a Saturday this year, you have two additional days to file your 2005 tax return. Tax returns must be postmarked by midnight on Monday, April 17, 2006.

Beginning in January, you will be receiving various tax documents such as W-2 forms and 1099 forms. You should store these tax documents in the same place as your other tax records in order to make your tax preparation easier.

The new standard deduction amounts this year are:

single taxpayers - \$5,000 married filing jointly - \$10,000 married filing separately - \$5,000 head of household - \$7,300

The new personal exemption amount you can claim for yourself, your spouse and your children is \$3,200 per person.

### THE NEW MEDICARE PRESCRIPTION DRUG COVERAGE

Choosing the right plan may appear to be an impossible task; the many types of insurance plans are mind-boggling. However, here are some resources to turn to for help in making your decision. Medicare has a publication called **Medicare & You, 2006** which includes a worksheet to help you choose a plan. You may go to the Medicare website at <code>www.medicare.gov</code>, or call Medicare's toll-free number: 1-800-633-4227.

Medicare is encouraging everyone who is Medicare-eligible to select and join a plan now, regardless of current prescription drug needs. If you join a plan after May 15, 2006, you will be subject to a penalty in the form of a permanently increased monthly premium.

Some dates to remember:

### January 1, 2006:

Date that Medicare Part D prescription coverage begins

### November 15, 2005 to May 15, 2006:

- · Enrollment period for the new prescription drug plans
- If you do not choose a plan during this time, you will be subject to the penalty, estimated at 1% per month for every month that you wait to enroll.
   This penalty will be paid as long as you have Medicare Part D prescription coverage.

### May 15, 2006:

• The last date you can enroll until November 15, 2006

### November 15, 2006:

The first date after May 15, 2006 you can enroll in a plan if you miss the May 15, 2006 deadline

### November 15 to December 31 of each year:

The time period in future years during which you can join or switch plans

All plans must provide at least the standard Medicare prescription benefit. Participants pay monthly premiums of \$32.20 per month, plus the first \$250 per year of drug expense, and approximately 25% of the cost of prescriptions up to the benefit limit of \$2,250. **Then there is a gap in coverage.** Participants must pay all drug expenses above \$2,250 until they reach \$5,100 in total prescription drug spending, after which Medicare will pay 95% of prescription drug cost. Some plans offer more coverage for a higher monthly premium.


Here are some things to consider in choosing a plan:

- If you're a senior with little to no drug expenses, consider a plan with extremely low monthly premiums (some are under \$20/month).
- If you want your drug expenses balanced throughout the year, consider a plan with no deductible.
- If your annual drug expenses are between \$2,250 and \$5,100, consider a plan that offers some coverage for the gap, or "doughnut hole".
- · Make sure that the specific drugs that you need are covered by your plan.
- · Although not permitted to recommend a specific plan, your pharmacist may be able to help you decide which plan best suits your needs.



# ENHANCING QUALITY OF LIFE FOR LAUREL AREA SENIORS

It is an everyday struggle for some people to remain independent in their own homes. Maintaining a house, purchasing groceries, household supplies and clothing, and getting to doctors' appointments can be not only an effort but also a physical impossibility. Many older people do not have a family member, neighbor or friend who can help them with these common, everyday tasks. It can be more than a matter of quality of life; it can involve issues of isolation and loneliness and meeting basic survival needs. The Laurel Area Interfaith Volunteer Caregivers (LAIVC) Faith in Action Program was founded in 2002 to address this growing problem.

The mission of the program is to enhance the quality of life for persons 60 years and older who reside in the Greater Latrobe and Ligonier areas by providing companionship and assistance. Partnering with 37 community groups, the LAIVC Faith in Action program is making a difference in the lives of many in these communities. In 3 short years, over 180 volunteers have been recruited, screened, and trained to assist 198 recipients with a variety of "quality of life" services. These volunteers have devoted over 8,000 hours of time providing rides to doctors' offices, trips to the grocery store, help with errands, friendly visits, assistance with correspondence and paying bills, relief for full-time caregivers, and routine household maintenance.

The program has built significant relationships with many community partners, including St. Vincent College and Adelphoi Village. Paid internships funded through PHEAA, credited programs, and service learning credits for volunteers through the college have helped to forge a strong connection between the college students and elderly in the community. Students from the various Adelphoi residential homes have had a dramatic impact on the lives of those struggling to remain independent in their homes. Providing snow shoveling in the winter, leaf raking in the fall, and lawn mowing in the summer, the students are able to experience the satisfaction of helping those who are frail, vulnerable, and in need.

The program demonstrates the many ways that neighbors working together with a shared purpose and mission can make a real difference. Faith In Action is an incubator that grows individual responsibility and initiative, kindness and philanthropy, community awareness and respect. This work helps to create a community that is a dynamic and expansive place where people want to live and raise families. Faith In Action brings together caring people with those who are unable to accomplish those activities of daily living many of us take for granted, to the benefit of each person and the greater community.

# MEDICAID ALERT!

Medicaid planning - that is, how you will pay for skilled nursing home care in the future - was changed dramatically through a federal law passed on February 8, 2006. New restrictions are being imposed on the ability to transfer assets to family members in order to qualify for Medicaid coverage of nursing home expenses. ANSWER: Both boys have troubles. Pennsylvania is a member of the Drivers License Compact (DLC), an agreement among 45 states designed to maximize traffic law enforcement efforts nationwide. Each state agrees to maintain a "one driver record concept" - a complete driver record in the driver's state of residence to determine driving eligibility both in the home state as well as other states. The DLC requires the reporting of all traffic convictions and license suspensions or revocations of out-of-state drivers to the home state.

Certain major offenses, when committed in another DLC state, are treated as though occurring in Pennsylvania and the appropriate sanction is imposed under Pennsylvania law. These offenses include homicide by vehicle, driving under the influence, failure to stop in the event of a serious accident, fleeing or eluding a police officer and any felony in which a vehicle is used.

Out-of-state minor traffic offenses such as speeding or stop sign violations do not get put on the Pennsylvania driving license record.

How does all this affect the roommates? Abe ran a stop sign and drove an uninspected vehicle in Missouri. Both offenses resulted in points on his Missouri record but would not be added to his Pennsylvania record.

In Texas, Zach sped and attempted to flee the police. The speeding does not have any effect, but fleeing or eluding is a suspendable offense. When it is reported by Texas, Pennsylvania will suspend Zach's license.

In Las Vegas, Zach was guilty of DUI. Nevada suspended his operating privilege for six months and forwarded the information to Pennsylvania. Since the suspension for DUI in Pennsylvania is one year, he will lose his operating privilege in Pennsylvania for that period.

With all this trouble, the buddies decided that their next trip would be to Georgia or Michigan, because those are 2 of the 5 states that are not members of the DLC, and would not affect their home state licenses!

The moral of the story is....be a good, safe driver and you won't have to worry about problems like this! For more information about the DLC, visit:
